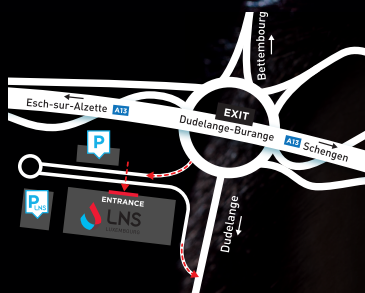

# OUR MISSION, OUR VALUES

**umedo** is a service for adult victims of **physical and/or sexual violence** who do not (for the time being) wish to involve the police and/or press charges.

The purpose of the service is to **document visible injuries** and secure **biological traces** in such a manner that evidence will be available for any legal proceedings in the future.

Since injuries heal and traces can sometimes be irretrievably lost within hours, it is essential to document these shortly after the event.



**APPOINTMENTS CAN BE MADE BY  
PHONE 24 HOURS A DAY, EVERY  
DAY.**

Specially trained doctors who are bound to medical confidentiality can carry out the examinations at the LNS or at one of the other hospitals listed overleaf.

The results of the examination are archived and can be requested whenever needed by the person examined.

Due to medical confidentiality, they will be issued only to third parties in possession of a written consent of the person examined.

# WHAT DOES UMEDO OFFER ?

- A free-of-charge documentation of injuries and securing of evidence which can be used in legal proceedings for adult victims of violence
- Confidentiality is guaranteed
- Archiving and subsequent issuing of the findings - at the request of the person examined - for later use (e.g. in legal proceedings)
- Providing contact links to assistance available from other support organisations
- Forensic medical examinations at the LNS or in one of the other hospitals listed overleaf, following phone appointments
